Upon receipt of the transferred shares (which may take up to two days or a few weeks in the case of mutual funds) and acceptance by SCCSS, SCCSS will issue you a tax receipt for the average of the high and low trading prices of the securities on the date that they are received in SCCSS's account and in accordance with Canada Revenue Agency regulations and SCCSS policy.
